INTERMEDIATE TRAINING FOR UK POLICE

BACKGROUND

The completion of this course indicates a basic understanding of the IAO role by the delegate who will now be able to start implementing this training into their new role as IAO and embrace their obligations.

WHO SHOULD ATTEND?

 - The SIRO Role & Legal Accountability
 - Your Information Security Officer

3. Introducing the principles of information assurance and information risk management, the importance of governance and leadership focussing on:

- Key Principles
- The Benefits
- Legal & Regulatory Compliance

- Risk Assessment
- Risk Appetite & Risk Tolerance

4. Introducing key aspects of threat and the current threat landscape to UK and Police information and ICT systems focussing on:

- Key Principles
- Threat Sources & Threat Actors
- Attack Methodologies
- Current Threat Levels
- Threat Assessments

At the end of the course IAOs will have a better understanding of their role and how to manage the assets under their control understanding how to assess risk and mitigate against it in the context of the asset.
