More and more charities are finding that Cyber Essentials (CE) or Cyber Essentials Plus is a mandatory requirement for new contracts and service delivery. But many charities do not have inhouse IT departments or security teams responsible for cyber security, and rely on outsourced service providers for IT support and expertise. Often there is also limited or no in-house information security knowledge either, so it can be difficult to know where to start when applying for CE or CE Plus and completing the necessary technical and information security information required.

WHAT IS THE CYBER ESSENTIALS SCHEME?

CE is a certification designed to help UK organisations display their secure approach to information and cyber security.

Level 1 (CE) comprises of five basic controls:

- Secure configuration
- Boundary firewalls and internet gateways
- User access and administration management
- Malware protection
- Patch management.

This is self-certified through a questionnaire with an external verification by an accredited certification body.

Level 2 (CE Plus) is a more rigorous assessment that requires an internal and external vulnerability assessment to be conducted by the certification body, in addition to your completion of the self-assessment.
