WHAT IS THE CYBER ESSENTIALS SCHEME?

Cyber Essentials is a certification designed to help UK businesses exploit and display their secure approach to information and cyber security.

Level 1 comprises of five basic controls:

- Secure configuration
- Boundary firewalls and internet gateways
- User access and administration management
- Malware protection
- Patch management

This is self-certified through a questionnaire with an external verification by an accredited certification body.

Level 2 (Cyber Essentials Plus), which became mandatory for UK Government suppliers from October 2014*, then a more rigorous assessment is required in addition to Level 1, an internal and external vulnerability assessment is completed.

WHY SHOULD THIS MATTER TO MY ORGANISATION?

Good cyber security is a business enabler and being able to demonstrate that you have good information governance at the heart of your organisation can help in many areas:

- You are hoping to bid for a Government contract in any of the sectors that have a mandatory requirement for Cyber Essentials*
- Survival in a tough and competitive business landscape
- Protection from the reputational damage a breach can cause
- Protection from job loss due to breach-enabled business damage
- Reduced Business Interruption or Cyber security insurance premiums
- Provide assurance for customers and other key stakeholders including supply chain partners
