# DATA PROTECTION COMPLIANCE REVIEW

## THE SITUATION

Within the UK all businesses have a legal obligation to comply with the Data Protection Act 2018 (DPA2018) when handling personal information. The rules apply whether you are a Data Processor, Data Controller, transmitting data within the UK, EU or elsewhere in the world.

In 2018 we adopted the EU General Data Protection Regulation (GDPR), now an augmented part of DPA2018. GDPR is still the regulation we adhere to post-Brexit, when there is movement of data into or out of the UK, within the EU, or the potential for EU citizen's personal data to be handled by the UK but stored further afield. Given that the sliding scale of monetary penalties for a data breach range from 2% to 4% of global turnover, or €10- €20m, commensurate with the severity of the breach, it is not something any Data Processor or Data Controller can afford to ignore.
